

Hours for Pool Key Operation: In the Event of an Emergency: 9:00 am until 9:00 pm Daily Call – 911

- This facility is for the exclusive use of Barcelona HOA residents and their guests ONLY.
- You must have a pool key to enter the pool area.
- Parents/Guardians are responsible for the actions of their family/friends and guests using the pool.
- Children under the age of 16 <u>MUST</u> be accompanied by an authorized Parent or Guardian.
- Homeowners must be "Current With Their Dues," for the pool card to stay active.
- No pets allowed in the fenced pool area.
- No smoking, including electronic cigarette devices, allowed inside the pool area.
- Glass containers are prohibited inside the fenced pool area at all times.
- No bicycles, roller blades, skateboards or others such items will be allowed inside the fenced pool area.
- Use of the pool facility while under the influence of alcohol, drugs or medication is prohibited.
- No diapers in the pool. Children requiring diapers must wear plastic watertight pants or swim diapers while using the pool.
- No diving/running or horseplay will be tolerated inside the pool area.
- Safety equipment is for EMERGENCY USE ONLY. These items should not be removed unless an emergency situation arises. (life rings and retrieval hooks)
- Only individual flotation devices are permitted. Multi-person floats are prohibited at all times.
- No football/soccer balls, etc. will be permitted in pool area. Only nerf balls will be allowed.
- Pool furniture is to remain on the pool deck at all times. Do not stand on or remove any furniture.
- Please place all trash in the receptacles provided. Remove and take with you the larger items that won't fit in receptacle when you leave the pool facility.
- No abusive language, loud radio or excessive noise will be tolerated.
- Children in baby pool must be supervised by an adult at all times.
- Persons with infectious diseases should not use the pool.
- The Homeowners Association assumes no responsibility for the loss, theft or damage to personal property or effects left in the pool area.

| Precise Location of the Pool on or with the Emergency Phone (address, or directions, or GPS location, or building number, as appropriate) | Minimum 1-inch |
| Hours of Operation | Minimum 1-inch |
| Directions to and Location of Emergency Phone if Phone Not Visible in Pool Yard | Minimum 2- inches |
| Maximum User Load Limit | Minimum 2- inches |
| "PETS IN THE POOL ARE PROHIBITED" | Minimum 2- inches |
| "DO NOT SWIM IF YOU HAVE BEEN ILL WITH DIARRHEA WITHIN THE PAST 2 WEEKS" | Minimum 2- inches |
| "CHANGING DIAPERS WITHIN 6 FEET OF THE POOL IS PROHIBITED" | Minimum 2- inches |
| "GLASS ITEMS NOT ALLOWED IN THE POOL YARD" | Minimum 2- inches |
| "PERSONS UNDER THE AGE OF 14 MUST NOT BE IN THE POOL WITHOUT ADULT SUPERVISION" | Minimum 2- inches |
| "EXTENDED BREATH HOLDING ACTIVITIES ARE DANGEROUS AND PROHIBITED" | Minimum 2- inches |
